## ***ABSTRACT***

*This research discusses Law Enforcement of Violations of the Installation of APK (Campaign Props) for the 2024 Election in Kediri Regency. Bawaslu has carried out active and passive control since the start of the campaign period in accordance with Bawaslu Regulation article 42 paragraph 2 and PKPU Number 11 of 2023. The Kediri Regency Bawaslu succeeded in ordering as many as 4,091 violating APKs and declared confiscated. The type of research used is empirical legal research, which is legal research that analyzes the application of law in reality to individuals, groups, communities, and legal institutions in society by focusing on the behavior of individuals or communities, organizations or legal institutions in relation to the application or enforcement of the law. From all the data obtained both through interviews and requests for data related to violations of the installation of campaign props above, researchers can conclude that there are efforts to enforce violations as evidenced by Bawaslu have carried out their duties and authorities correctly, but there are elements that hinder them, such as undeterred sanctions, lack of social enthusiasm, time and supporting facilities, and efforts to manage campaign props. Related to the inhibiting factors in law enforcement against violations of the installation of campaign props in Kediri Regency in the 2024 election include sanctions that lack a deterrent effect, factors that lack social enthusiasm, limited personnel, limited facilities and facilities.*
